




President's Message....

Executive Board has appointed Dr. Jaydeep Tank, Deputy Secretary-General, in charge of the Past YGAAs. Read more...


Finally, I request everyone to take it easy until the condition improves and stay safe and assist in helping to prevent the spread of the COVID-19 and look after the pregnant mothers.

AOFOG statement on coronavirus disease COVID-19



AOFOG views with great concern the current outbreak of COVID-19 infection since December 2019. Although the epicenter of this infection was in Wuhan city in China, the infection has since spread to many other countries in and outside of Asia. The situation is evolving and although it has resulted in mortality, the Case Fatality Rate is yet to be determined.

Historically, pregnant women have been disproportionately affected by respiratory illnesses presumably due to their immunosuppressed state. Data from the SARS epidemic of 2003 pointed to a poorer outcome among pregnant women (1). Based on limited data from COVID-19 cases, it is considered that pregnant women may be at higher risk of severe illness, morbidity, or mortality compared with the general population (1-3). However, pregnancy-specific data is currently lacking and we advise continued vigilance until more data becomes available.

As there are no specific clinical signs and symptoms of COVID-19 infection, a high index of suspicion is required. We advise our pregnant women and health care providers to adhere to strict infection prevention and control measures to limit acquiring and transmission of the infection. Currently, there is no specific treatment or vaccine available for COVID-19 and suspected cases should be referred for isolation and supportive care in designated centres with specialised infection control facilities as per local guidelines.

At present, there is no reliable evidence of vertical transmission from the mother to the baby (4). Neonates of mothers with suspected or confirmed COVID-19 should be isolated and it would be prudent to consider expressed breast milk to avoid close contact with the mother. These decisions should be made in consultation with the family and the healthcare team.

AOFOG reiterates the importance of primary infection control measures such as those employed during the epidemics of SARS in 2003 and MERS in 2012. We further endorse the WHO guidelines for the general safety and prevention of the spread of COVID-19 which can be accessed via the link below:

AOFOG will keep abreast of developments and provide our obstetric community with updates as more information becomes available.

Updated Statement (25 March 2020) on coronavirus disease COVID-19

In the short time since our previous statement, the situation with regards to COVID 19 has changed very rapidly. It has now spread to more than 190 countries throughout the world, resulting in the WHO declaring it a pandemic on the 11th March 2020.

Wuhan province in China appears to be recovering with very minimal progression due to continued strict hygienic and health precautions coupled with possible herd immunity.

To date, only limited data is available on clinical presentation and perinatal outcomes after COVID-19 during pregnancy and puerperium. The large majority of women will experience only mild to moderate cold/flu-like symptoms. Cough, fever, and shortness of breath are other relevant symptoms. Only one case requiring extracorporeal membranous oxygenation has been reported. Asymptomatic transmission of COVID-19 may be possible and all pregnant women with an epidemiologic history of contact should be carefully monitored and quarantined/self-isolated for two weeks.

There is still no good evidence of vertical transmission from mother to child as evidenced by negative samples in vaginal secretions, cord blood, amniotic fluid, and breast milk. There is uncertain evidence to show increased maternal and perinatal mortality or morbidity.

Pregnant mothers suspected of infection should be screened with the COVID-19 viral swab test and triaged according to the WHO guidance once diagnosed positive. The involvement of a multidisciplinary team is essential in comprehensive care and management for improved outcomes. Continuous fetal monitoring is advised as there is potential for increased risk of fetal hypoxia in labour. Decisions on the mode of delivery should be dictated by obstetric/medical indications. All Obstetric units are encouraged to develop a standard protocol in managing suspected or infected mothers in consultation with hospital administrators, midwifery staff, infectious disease physicians and intensivists to ensure a positive outcome for both patients and healthcare providers.

Breastfeeding protects against morbidity and mortality in general and should be promoted in infected mothers with standard infant feeding guidelines. The use of a face mask by the infected mother in tandem with other general hygienic measures like hand washing is strongly advised while feeding to avoid transmission. Expressed breast milk can be used for infants of mothers isolated due to the severity of the respiratory illness. As always, decisions on infant feeding should be made in consultation with the family after an adequate explanation of the pros and cons.

There has been increasing concern recently of exposure of health care providers to COVID 19. Needless to say, protocols for Personal Protective Equipment (PPE) should be in place for their adequate protection and safety.

6th Intensive Course in Obstetric Emergencies (ICOE) in Vientiane, Laos

The Laos Association of Obstetrics and Gynecology (LAOG) together with the Obstetrical & Gynecological Society of Malaysia (OGSM) jointly organised the ICOE on 28th - 29th of February 2020 in collaboration with the AOFOG. This is our sixth visit to Laos, after initiating the first ICOE in November 2017. Over the last 30 months, we have organized and completed five courses in two different provinces, namely Vientiane and Luang Prabang and have trained 123 doctors from various provinces in Laos. At the same time, we have also had one train the trainer (TOT) course in 2018 and a refresher course in 2019 and we now have 14 capable Lao trainers.





This two-day course was conducted at the Mother and Newborn Hospital, Vientiane where 32 participants were trained. The participants were Obstetricians from the various provinces of Laos. The course was honoured by the presence of the President of AOFOG, Prof. Kazunori Ochiai. Prof. Alongkone

represented LAOG as the secretary together with the President of LAOG, Dr. Anan Sacdpraseuth as well as the director of the Mother and Newborn Hospital. Dr. Muniswaran was the ICOE course director from OGSM.

The OGSM trainers were Drs Melanie Kuan, Thawaneswaaran, Yong Soon Leong and Mr. Baskeran as ICOE executive. The Mongolian trainers were Drs Sittysack, (Head) Panima, Anusone, Sengaloun, Sengchanh, Vanpaseud, Svamphai, Vixay, Phetsamone, Souphaphone, Sisamphone, Johnny, Monglor, Vilaxonh, Souphany, Sonephachan, Sanack, Viengkham, and Khamhou.

At the opening ceremony, Prof. Ochiai spoke on the role of AOFOG and assured his continued support for this course in Laos and the region.

This course was conducted almost entirely by the Lao trainers with minimal supervision from the OGSM trainers. Most of the simulation was conducted in the Lao language. The presence of the OGSM trainers in each breakout ensured the course stayed to the core objectives and managed within the stipulated time.





The success of this course was evident based on the improvement between the participants' pre and post-tests performance which showed a significant increase after the course. The participants too felt they were engaged and that their objectives were met while having had a simulation, hands-on enjoyable course with focused feedback.

This course was also special in the form of a fellowship dinner and a guest lecture by Prof. Ochiai who delivered an excellent lecture titled "Research Mind and Evidence-Based Medicine" to the members of LAOG and ICOE trainers which were very well received.





The course once again proved popular and was well received and there is a demand for ICOE to continue in Laos. The local trainers proved they are capable to deliver the course independently while maintaining the required standards and prerequisites. Among the future plans between LAOG and OGSM is perhaps to assist the LAOG in running these courses

independently while supporting them in various provinces, especially in areas of need. Discussions are in place to initiate a midwifery course in Laos which may also have a significant impact in terms of reducing maternal and neonatal mortality and morbidity which is still a major concern in Laos.

The lack of funding, resources, and equipment are the common challenges especially to sustain the quality of such a simulation-based course in obstetric emergencies and thus the continued support from AOFOG is crucial and much welcomed by LAOG.

This collaboration would not have been successful if not for the able leadership of Prof. Alongkone who has been instrumental in the ICOE chapter in Laos and we will like to note heartfelt gratitude for his vision and leadership.

We hope to continue this strategic collaboration within LAOG, OGSM, and AOFOG as we continue our endeavor in making childbirth safe, every time, everywhere. We believe we have made a change.
